

## **8.2.1 Data privacy policy for GLAUB Automation Kft.**

### **1. Privacy policy**

We, the GLAUB Automation Kft., strongly value compliance with data protection laws. We comply with the relevant data protection laws in their entirety, in particular the EU GDPR and the Federal Data Protection Act (new). The processing of personal data exclusively takes place on the basis of the relevant laws and only takes place for the purposes stated under No. 4. These data are only processed in accordance with this privacy policy.

### **3. Collecting the data**

We collect, save and process the following data categories to fulfil the contractual and legal regulations:

- Company data (e.g. name and address of contractor)
- Personal data (e.g. name, address of contact person at contractor)
- Contact data (e.g. telephone number, email address of contact person)
- Other data (e.g. position of contact person)

### **4. Purpose of data processing**

We process the data mentioned in No. 3 exclusively for the following purposes e.g.:

1. to fulfil contracts
2. to fulfil legal, judicial or official provisions/instructions
3. to provide information about our service portfolio and events
4. for implementing anonymised statistical evaluation such as e.g. satisfaction analyses

### **5. Data transmission**

Data transmission is implemented according to the fulfilment of contractual and legal regulations as stated in point 3- data collection as well as in point 4 - purpose of data processing.

### **6. Data transmission to a third country**

Data transmission to third countries does not take place and is not planned either.

## 7. Deletion periods

The personal data saved by us are deleted or anonymised after the purposes stated in No.4 are no longer applicable or the expiry of any applicable legal retention periods.

## 8. Rights of the Data Subject

You have the right to receive information regarding the data saved regarding your person. Furthermore, you have the right to rectification, deletion, and limitation of processing and data transmission.
